Excellency,



ON THE RE-ESTABLISHMENT OF THE DIPLOMATIC RELATIONS
BETWEEN
THE REPUBLIC OF COSTA RICA
AND
THE REPUBLIC OF LEBANON**

The Government of the Republic of Costa Rica and the Government of the Republic of Lebanon,


Desirous to promote the spirit of mutual understanding and to develop ties of friendship and cooperation between their two countries and peoples, based on the principles of the United Nations Charter and international law, particularly international peace and security, juridical equality among states, respect of national sovereignty, independence, respect for international treaties, territorial integrity and non-interference in the internal affairs of States,

Have agreed to re-establish diplomatic relations, at the ambassadorial level, between the two countries in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as from the date of signing of this Joint Communiqué.

In witness thereof, the undersigned, being duly authorized by their respective Governments, have signed this Joint Communiqué in two originals, in the Spanish and English languages, the two texts being equally authentic.

El Gobierno de la República de Costa Rica y el Gobierno de la República de Líbano,

Deseosos de promover el espíritu de cooperación y entendimiento mutuo y de desarrollar lazos de amistad y cooperación entre sus dos países y pueblos, basados en los principios de la Carta de las Naciones Unidas y del Derecho Internacional, particularmente de la paz y la seguridad internacionales, la igualdad jurídica de los Estados, el respeto de la soberanía nacional, la independencia, el respeto por los Tratados Internacionales, la integridad territorial y la no interferencia en los asuntos internos de los Estados,

Han acordado restablecer relaciones diplomáticas a nivel de embajadores, entre ambos países, de conformidad con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961 a partir de la firma de este Comunicado Conjunto.
