

JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

BETWEEN

THE REPUBLIC OF PARAGUAY

AND

THE REPUBLIC OF BOTSWANA

The Governments of the Republic of Paraguay and the Republic of Botswana guided by their mutual willingness to promote mutual understanding and strengthen the friendship and co-operation between their peoples, based on the principles and purposes of the Charter of the United Nations and international law and treaties, particularly with respect to and promotion of international peace and security, equality among States, national sovereignty, independence, territorial integrity and non-interference in the internal affairs of other States, have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed in duplicate this Joint Communiqué in the English and Spanish languages, both texts being equally authentic.

**COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS
ENTRE LA REPUBLICA DEL PARAGUAY
Y LA REPUBLICA DE BOSTWANA**

La República del Paraguay y la República de Bostwana, guiados por la voluntad común de promover el entendimiento mutuo y de estrechar la amistad y cooperación entre ambos pueblos, basados en los principios y propósitos de la Carta de las Naciones Unidas, del Derecho Internacional y los tratados, particularmente en lo que respecta a la promoción de la paz internacional y la seguridad, la igualdad entre los Estados, la soberanía nacional, la independencia, la integridad territorial y la no interferencia en los asuntos internos de otros Estados;

Han decidido establecer relaciones diplomáticas, al nivel de Embajadores, conforme a las previsiones de la Convención de Viena sobre Relaciones Diplomáticas, del 18 de abril de 1961, a partir de la fecha del presente Comunicado Conjunto.

En fe de lo cual, los abajo firmantes, debidamente autorizados por sus respectivos Gobiernos, firman el presente Comunicado Conjunto en dos ejemplares originales, en los idiomas español e inglés, siendo ambos textos igualmente auténticos.
