ADOPTION OF THE AGENDA OF THE FOURTH REGULAR SESSION AND ALLOCATION OF ITEMS TO COMMITTEES

Report of the General Committee

The General Committee, at its 65th meeting held on 21 September 1949, considered the provisional agenda (A/932), the supplementary list of items (A/964), requests for the inclusion of additional items (A/970, A/980) and the allocation of agenda items to committees. The Committee also considered a memorandum of the Secretary-General on the organization of the session (A/BUR/120).

I. ADOPTION OF THE AGENDA

1. The General Committee, having been informed of the resignation of Costs Rica from the Trusteeship Council, considered the former's request (A/980) for the inclusion of an additional item in the agenda "Election of a new member of the Trusteeship Council", and on the proposal of the Secretary-General, decided to recommend the amendment of item 15 of the provisional agenda to read as follows:

"Election of three members of the Trusteeship Council".

2. With the concurrence of the delegation of Australia, the General Committee recommends that item 27 of the provisional agenda and item 3 of the supplementary list be combined to read as follows:

"Observance in Bulgaria, Hungary and Romania of human rights and fundamental freedoms".

3. On the proposal of the Secretary-General, the General Committee recommends that item 28 of the provisional agenda and item 6 of the supplementary list be combined to read as follows:

"Economic development of under-developed countries:

- "(a) Economic development of under-developed countries: report of the Economic and Social Council

The General Committee, in view of the suggestion of the delegation of Niceregus that a fitting tribute could be sesociated with the completion of the United Nations permanent headquarters, therefore recommends that this item should not be included in the agenda.
- 8. The General Committee was informed by the delegation of Argentina that it had withdrawn its request (A/970) for the inclusion of an additional item in the agents, "Calling of the General Conference referred to in Article 109 of the Charter". The General Committee therefore recommendates that this item should not be included in the agenda.

IV. ORGANIZATION OF THE FOURTH SESSION OF THE GENERAL ASSEMBLY

- 13. On the proposal of the Secretary-General, the General Committee recommends that the General Assembly approve the following arrangements relating to the schedule of meetings:
 - (a) That both plenary and committee meetings shall begin at 10.45 a.m. and 3.00 p.m.
 - (b) That a six-day working week be established, and that night meetings be held whenever necessary
 - (c) That in the initial stages of the Committees' work four Main Committees be scheduled to meet each morning and four each afternoon.
