Note by the Secretary-General

The Secretary-General has the honour to transmit to the members of the General Assembly, for their information, the attached note from the United Nations Administrative Tribunal to the President of the General Assembly.

ANNEX

Annual note by the United Nations Administrative Tribunal

1. At its third plenary session, held in Paris on 20 December 1951, the Administrative Tribunal decided to submit a note each year to the President of the General Assembly. In accordance with this decision, the following note is submitted in respect of the year 1991.

I. APPOINTMENT OF MEMBERS OF THE TRIBUNAL BY THE
GENERAL ASSEMBLY

2. At its 72nd plenary meeting, on 21 December 1990, the General Assembly, on the recommendation of the Fifth Committee (see A/45/864), appointed Mr. Ioan Voicu and Mr. Luis de Posadas Montero as members of the United Nations Administrative Tribunal for a three-year term of office beginning on 1 January 1991.

V. SESSIONS SCHEDULED FOR 1992

6. Taking into consideration the number of cases already submitted to it, the Tribunal decided that the first ordinary session, referred to in article 6, paragraph 2, of its rules, would be held at the United Nations Office at Geneva beginning on 1 June 1992, and that its second session would be held at Headquarters during the last quarter of 1992, pursuant to articles 5.1 and 6.2 of its rules.

7. The Tribunal must reiterate even more strongly than in previous notes its concern at the mounting volume of litigation, which has already caused the Tribunal to meet for longer periods than in the past and which required that the Tribunal meet three times during 1991 because of the limited number of cases that the Tribunal can consider at a single session.

8. The Tribunal has asked the Secretary-General for two additional posts: one Professional post at the P-3 level is required for an Assistant Secretary of the Tribunal and one General Service post is needed to complete the computerized index of decisions and to help in avoiding a backlog. While the Secretary-General has provided those posts to the Tribunal on a temporary basis during 1991, the Tribunal expresses the hope that these posts will now be provided on a permanent basis.
