APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS: CONFIRMATION OF THE APPOINTMENT OF MEMBERS OF THE INVESTMENTS COMMITTEE

Note by the Secretary-General

- 1. As indicated in document A/46/104 of 1 March 1991, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of three persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 1991, of the terms of office of Mr. Aloysio de Andrade Faria (Brazil), Mr. B. K. Nehru (India) and Mr. Stanislaw Raczkowski (Poland). Mr. Nehru, who has served on the Investments Committee since 1962, has indicated, unfortunately, that he is not available to serve another term. It is proposed that Mr. Ahmad Abdullatif (Saudi Arabia), who has served as an ad hoc member of the Committee since 1984, be appointed to replace Mr. Nehru.
- 2. In addition, as indicated in document A/46/104/Add.1 of
 26 September 1991, it will be necessary to confirm the appointment of one
 person to fill the unexpired term of office of Mr. George Johnston (United
 States of America), who unfortunately died in February 1991. His term would
 have expired at the end of 1993. To replace Mr. Johnston, the
 Secretary-General has proposed the appointment of Ms. Francine Bovich (United
 States of America).
- 3. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund (UNJSPF), the Secretary-General, after consultation with the United Nations Joint Staff Pension Board (UNJSPB) and the Advisory Committee on Administrative and Budgetary Questions (ACABQ), submits for confirmation by the General Assembly the appointment of Mr. Abdullatif and the reappointment of Mr. Faria and Mr. Raczkowski as

members of the Investments Committee for three-year terms of office beginning on 1 January 1992, and the appointment of Ms. Bovich to complete the three-year term of Mr. Johnston, expiring 31 December 1993.

- 4. Mr. Abdullatif has served on the Committee as an ad hoc member since 1984, Mr. Faria since 1976 and Mr. Raczkowski since 1977. Ms. Bovich will be a new member. The Secretary-General very much appreciates their willingness to carry on this important international public service.
- 5. The curricula vitae of the appointees for confirmation are set out in the annex to the present document.
- 6. In accordance with past practice, the Secretary-General also proposes to appoint as ad hoc member Mr. Peter Stormonth-Darling (United Kingdom of Great Britain and Northern Ireland) to serve with the Committee in 1992.
