### APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

#### Appointment of members and alternate members of the United Nations Staff Pension Committee

#### Report of the Fifth Committee

Rapporteur: Mr. Mahmoud BARIMANI (Islamic Republic of Iran)

1. At its 51st meeting, on 13 December 1991, the Fifth Committee considered a note by the Secretary-General (A/46/106) concerning the appointment of four members and four alternate members to fill vacancies that will arise in the membership of the United Nations Staff Pension Committee, effective 31 December 1991.

2. The Fifth Committee also had before it a note by the Secretary-General (A/C.5/46/55 and Add.1) containing the names of the following 10 persons nominated by their respective Governments for appointment or reappointment to the Staff Pension Committee for a three-year term of office beginning on 1 January 1992:

Mr. Mohamed Férid Belhaj (Tunisia)

Mr. Leonid E. Bidny (Union of Soviet Socialist Republics)

Mr. Jorge Duhalt (Mexico)

Mr. Tadanori Inomata (Japan)

Mr. Nathan Irumba (Uganda)

Mr. Richard Kinchen (United Kingdom of Great Britain and Northern Ireland)

Mr. M'hand Ladjouzi (Algeria)

Mr. Michael G. Okeyo (Kenya)

Mr. Ranjit Rae (India)

Ms. Susan Shearouse (United States of America).

3. At the same meeting, the Fifth Committee was informed that the Governments of Algeria and Uganda had decided to withdraw the candidature of Mr. M'hand Ladjouzi and Mr. Nathan Irumba, respectively, for appointment to the Staff Pension Committee.

4. The Chairman announced that the candidates themselves had expressed the wish that Messrs. Jorge Duhalt, Tadanori Inomata and Michael G. Okeyo and Ms. Susan Shearouse be considered for the vacancies as members and that Messrs. Mohamed Férid Belhaj, Leonid E. Bidny, Richard Kinchen and Ranjit Rae as alternate members.

5. The Fifth Committee decided, by acclamation, to recommend the appointment of the candidates as indicated in paragraph 4 above.

#### RECOMMENDATION OF THE FIFTH COMMITTEE

6. The Fifth Committee recommends that the General Assembly should:

(a) Appoint the following persons as members of the United Nations Staff Pension Committee for a three-year term of office beginning on 1 January 1992:

Mr. Richard Kinchen

Mr. Ranjit Rae.
