REPORT OF THE ECONOMIC AND SOCIAL COUNCIL

Report of the Third Committee

Rapporteur: Ms. Rosemary SEMAFUMU (Uganda)

I. INTRODUCTION

1. The Third Committee considered the question of the rationalization of the work of the Third Committee at its 2nd, 58th and 60th meetings, on 2 October, and 10 and 11 December 1991. An account of the Committee's discussions of the question is contained in the relevant summary records (A/C.3/46/SR.2, 58 and 60).

2. At its 2nd meeting, on 2 October 1991, the Third Committee decided to establish an informal open-ended Working Group on the Rationalization of the Work of the Third Committee, under the Chairmanship of Mr. Florian Krenkel (Austria), to consider outstanding issues on the rationalization of the work of the Third Committee and to submit a draft biennial programme of work for the Third Committee for 1992-1993.

3. The Working Group met on 25 and 31 October and on 4 and 5 December 1991.

4. At the 58th meeting, on 10 December, the Committee had before it the report of the Working Group on the Rationalization of the Work of the Third Committee (A/C.3/46/L.68).

5. At the 60th meeting, on 11 December, the Secretary of the Committee informed the Committee of the revisions to the text in the light of the adoption of draft resolution A/C.3/46/L.61/Rev.1 and the draft resolution in section II.A of document A/46/703, and draft resolution A/C.3/46/L.67. The

Secretary of the Committee also added a report of the Ad Hoc Working Group of Experts on Southern Africa (Economic and Social Council decision 1991/237).

6. At the same meeting, the Committee approved the recommendations of the Working Group as contained in its report (A/C.3/46/L.68), as orally revised (see para. 7).

II. RECOMMENDATION OF THE THIRD COMMITTEE

7. The Third Commtitee recommends to the General Assembly the adoption of the following draft resolution:

Rationalization of the work of the Third Committee, including the biennial programme of work of the Committee for 1992-1993

The General Assembly

1. <u>Takes note</u> of the report of the Working Group on the Rationalization of the Work of the Third Committee; 1/

2. <u>Reaffirms</u> the recommendations on the rationalization of the work of the Third Committee contained in General Assembly resolution 45/175 of 18 December 1990 and recommends further measures on the organization of its work, as outlined in annex I to the present resolution;

3. <u>Approves</u> the biennial programme of work of the Third Committee for 1992-1993, as contained in annex II to the present resolution;

4. <u>Requests</u> the Secretary-General to draw up the provisional agenda for the Third Committee of the General Assembly at its forty-seventh session in accordance with the present resolution.

ANNEX I

FURTHER MEASURES FOR THE RATIONALIZATION OF THE WORK OF THE THIRD COMMITTEE

A. <u>Guidelines concerning time-limits and number of statements</u> by delegations and Secretariat officials

1. In accordance with rule 106 of the rules of procedure of the General Assembly and paragraph 22 of decision 34/401 on the rationalization of the procedures and organization of the General Assembly, at the beginning of each session, the Chairman should propose to the Third Committee the limitation of the time to be allowed to speakers.

2. Further to General Assembly resolution 45/1/5 of 18 December 1990, on the rationalization of the work of the Third Committee, statements made by delegations or on behalf of groups of delegations and by Secretariat officials, unless decided otherwise by the Committee at the beginning of the session, should not exceed 15 minutes. This time-limit will have to be applied with a degree of flexibility towards all speakers. With a view to saving time, all speakers are encouraged to exercise self-discipline, in particular delegations associated with group statements. For practical reasons, group statements are encouraged for the first day of the discussion of an item or sub-item. In this connection, it is important to emphasize the timely distribution of documentation in accordance with the rules of procedure of the General Assembly, in order to enable delegations to inscribe themselves on the list of speakers at an early stage.

Introductory statements by Secretariat officials

3. In addition to the provisions contained in General Assembly resolution 45/175 concerning introductory statements by Secretariat officials, introductory statements should be made at the beginning of the discussion of an item.

Statements under items entitled "Elimination of racism and racial discrimination" and "Right of peoples to self-determination"

4. In accordance with General Assembly resolution 45/175, the above items are to be discussed jointly.

5. Delegations wishing to make two separate statements, i.e., one on each of the above items may do so.

Statements under the item entitled "Social development"

- (a) <u>Questions relating to the world social situation and to youth</u>, <u>ageing</u>, <u>disabled persons and the family</u>;
- (b) Crime prevention and criminal justice.

In accordance with General Assembly resolution 45/175, sub-items (a) and
(b) are to be discussed separately.

7. Delegations wishing to make two separate statements under sub-item (a) may do so.

Statements under the item entitled "Human rights questions"

- (a) Implementation of human rights instruments;
- (b) <u>Human rights questions, including alternative approaches for</u> <u>improving the effective enjoyment of human rights and fundamental</u> <u>freedoms</u>;
- (c) <u>Human rights situations and reports of special rapporteurs and</u> representatives.

8. In its resolution 45/175, the General Assembly recommended that sub-item (a) be discussed separately, and sub-items (b) and (c) be discussed jointly.

9. Delegations wishing to make two statements under this item may do so, but no statement should be made on any of the sub-items twice.

B. Introduction of draft resolutions

10. Introductory statements of draft resolutions should be as brief as possible.

C. <u>Draft resolutions on reports of treaty bodies and reports</u> of the Secretary-General on the status of those treaties

11. Reports of all treaty bodies will, in accordance with their respective legislative mandates, be submitted to the General Assembly annually. Substantive resolutions on those reports should be adopted biennially, in accordance with the programme of work of the Third Committee. Where possible, it is recommended that separate draft resolutions on the status of the treaties not be submitted but incorporated in the draft resolution relating to the report of the treaty body. In alternate years, the Committee should simply take note of the reports unless more substantive action is deemed appropriate.

D. <u>Draft proposals glanating from subsidiary organs of</u> the Economic and Social Council

12. The Economic and Social Council, in transmitting draft proposals to the General Assembly should, to the extent possible, bear in mind the programme of work of the Third Committee.

E. Organization of work

13. An informal meeting of the Third Committee should be held immediately after the election of the members of its Bureau in order to consider the programme of work of the Third Committee based on a draft to be prepared by the Secretariat and to consider other organizational aspects relating to the Committee's work, especially the status of documentation.

14. The items allocated to the Third Committee during the forty-seventh session of the General Assembly should be taken up in the following order:

- <u>Item 3.</u> Right of peoples to self-determination 2/
- Item 4. Social development

15. This arrangement may be reviewed at the Third Committee's organizational meeting, particularly in the light of the status of documentation at that time.

F. <u>General guidelines regarding the preparation and submission</u> of draft resolutions

16. In drawing up draft resolutions, delegations are requested to adhere to the programme of work of the Third Committee agreed to in General Assembly resolution 45/175 and as reproduced below.

17. If a report is deemed necessary, clear indications should be given in the draft resolution regarding the contents, scope and nature of the report requested.

18. Delegations should be urged not to request the inscription of a separate item on the agenda of the Third Committee of the General Assembly if the subject-matter can be dealt with under the existing agenda items indicated in General Assembly resolution 45/175.

19. With a view to ensuring adequate time for the proper consideration by the Third Committee of draft proposals, delegations are encouraged to circulate their draft texts as early as possible.

20. In this connection, delegations are invited to take into account the general guidelines agreed upon in General Assembly resolution 45/175 regarding the submission of draft proposals, as set out below: 7/
