WORLD CONFERENCE ON HUMAN RIGHTS

Voluntary fund for the participation of least developed
countries in the World Conference on Human Rights and the
preparatory process thereto

Report of the Secretary-General

1. The General Assembly, in its resolution 46/116 of 17 December 1991, reiterated its invitation for contributions of extrabudgetary resources to meet the costs of participation of representatives of the least developed countries in the World Conference on Human Rights and in its preparatory meetings, including regional meetings. It also requested the Secretary-General to intensify his efforts in this regard.
2. A note and explanatory memorandum (see annex) were sent to all States on 10 January 1992, soliciting contributions to the voluntary fund established for this purpose and advising them of the amount required to cover the costs of travel of representatives of the least developed countries in the various meetings of the preparatory process and the World Conference itself.
3. At the time of the preparation of this report, contributions had been received from Finland, Ireland, Morocco and the Netherlands. The total amount so far contributed is \$US 192,647. In addition, the Secretary-General had been informed of the decisions of Norway, Sweden and France to contribute \$US 30,000, Skr 300,000 and FF 100,000, respectively, to the fund.
4. The Secretary-General reiterates his appeal to States which may be in a position to do so to contribute to the fund. In this regard it will be recalled that the target figure needed to meet the financial requirements for participation by the least developed countries in the World Conference on Human Rights and its preparatory process is approximately \$US 690,000.

The Secretary-General of the United Nations presents his compliments to and has the honour to refer to General Assembly resolution 45/155, as well as resolution 1991/30 of the Commission on Human Rights, relating to the World Conference on Human Rights. Pursuant to these resolutions, the Secretary-General was requested to invite contributions of extrabudgetary resources to meet, inter alia, the costs associated with participating in the preparatory process and the World Conference for representatives of the States identified by the General Assembly as the least developed countries.

At its forty-sixth session, the General Assembly endorsed the decisions of the first session of the Preparatory Committee of the World Conference on this subject, and called upon the Secretary-General to intensify his efforts in seeking contributions for this purpose.

A voluntary fund has now been established for the specific purpose of defraying the travel expenses of representatives of the least developed countries.

Contributions to the fund may be made in one of two ways:

Subject to the levels of contribution, travel costs for one representative of each of the 42 least developed countries would be defrayed, in accordance with the applicable rules. Accordingly, travel would be authorized on the basis of a full fare round trip economy class ticket, or business class for air travel longer than nine hours.

* Cambodia, Madagascar, the Solomon Islands, Zaire and Zambia have since been added to the list of least developed countries. The total amount required for the fund is therefor estimated at \$US 690,000.
