LETTER DATED 28 AUGUST 1987 FROM THE CHARGE D'AFFAIRES A.I. OF
THE PERMANENT MISSION OF THE ISLAMIC REPUBLIC OF IRAN TO THE
UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

Upon instructions from my Government, I have the honour to inform you that the Iraqi forces have intensified their indiscriminate attacks against civilian and non-military quarters inside the Islamic Republic of Iran since 25 July 1987. The details of these attacks, including the number of civilian casualties, between 25 July and 18 August 1987 are as follows:

- 7/25/87 - Bombardment of an agricultural area between the villages of Darreh Taqhi and Kani Saman in the vicinity of Marivan - 4 farmers martyred
- 7/26/87 - Bombardment of the village of Ganjavan in the Chavar District of Ilam - injury to some villagers
- 8/10/87 - Bombardment of two oil facilities in the Ramhormoz area - 6 martyred and 38 injured
- 8/10/87 - Bombardment of the Tabriz refinery - 1 martyred and 12 injured
- 8/10/87 - Bombardment of the Aghajari oil installations - 8 martyred and 35 injured
- 8/10/87 - Bombardment of the Bibikalimeh in Gachsaran - 15 martyred and 40 injured
- 8/10/87 - Bombardment of the Haezan oil installations in the north of Ramhormoz - 6 martyred and 38 injured
- 8/13/87 - Bombardment of the villages of Darmanabad, Abbasabad and Mirpanj Heidar in Sardasht - 1 martyred and 6 injured
- 8/16/87 - The village of Yaroomi, 17 kilometres from the Ahwaz-Mashhad road became the target of rockets and its people the targets of machine-gun fire - a 7-year-old child martyred and 2 injured
- 8/16/87 - at 9.25 hours (local time) - Bombardment of oil exploitation units Nos. 1 & 2 in Ahwaz

8/17/87 - At 14.30 hours (local time) - Bombardment of oil exploitation unit No. 1 in Ahwaz - 6 injured

8/17/87 - At 16.50 hours (local time) - Aerial bombardment by 2 aircraft of the Karoon Agriculture & Industry in Shooshtar (rockets used) - 4 martyred and 5 injured

8/17/87 - At 16.45 and 16.55 hours (local time) - Bombardment of the Pars Paper Manufacturing Company in Haft Tappeh - 25 martyred and 37 injured

8/18/87 - Bombardment of Narvan and Aghajari oil installations, unit 2 in Gachsaran and Ramin power station in Ahwaz

8/18/87 - At 16.20 hours (local time) - Bombardment of oil exploitation unit No. 2 in Baloot plateau and gas exploitation unit No. 3 in Gachsaran

8/18/87 - At 16.20 hours (local time) - Bombardment of a town and village in the vicinity of Sepan
