Introduction

1. As indicated in paragraph 15.1 of the programme budget proposals for the United Nations Conference on Trade and Development (UNCTAD) (A/42/6 (Sect. 15)), a revised submission of the proposals was to be prepared in response to decisions taken at the seventh quadrennial session of UNCTAD, held from 9 July to 3 August 1987. The revised proposals are presented in section I of this document. In section II, revised estimates are given in the light of developments for bringing the Common Fund for Commodities into operation.

I. SEVENTH QUADRENNIAL SESSION OF THE UNITED NATIONS CONFERENCE ON TRADE AND DEVELOPMENT

- 2. The proceedings of the seventh session of UNCTAD and the adoption by consensus of its Final Act can be seen as an important step in the evolution of the activities of UNCTAD on the basis of the initial mandate given to it by the General Assembly in resolution 1995 (XIX). Although not covering the whole range of UNCTAD's concerns, the Final Act gives new impetus to work by Governments and the secretariat in several key areas of activity.
- 3. While providing substantive support to Governments in implementing, adapting and strengthening agreed policy approaches and concrete measures, the UNCTAD secretariat must also enhance its capacities for policy-oriented research, analysis and conceptual innovation so as to continue to be able to prepare substantive proposals on issues coming within the purview of UNCTAD for intergovernmental deliberation and negotiation in the future. Moreover, the secretariat is called upon to strengthen its capacity to respond to the growing need of developing countries for technical co-operation in areas where UNCTAD can furnish substantive expertise.
- 4. The revision affects five programmes and focuses on the programmatic aspects: programme 1 (Money, finance and development); programme 2 (Commodities); programme 3 (Manufactures and semi-manufactures); programme 7 (Trade among countries having different economic and social systems); and programme 8 (Least developed, land-locked and island developing countries). One new programme element (programme 8, element 1.2) has been added, the priority designation of five programme elements changed, three programme element titles revised and 54 programme outputs reformulated or newly introduced. They are proposed to be implemented within the financial resources requested in the context of the programme budget for the biennium 1988-1989 (A/42/6 (Sect. 15)).
- 5. These revisions are the first response of the UNCTAD secretariat, within the constraints of the time available since the end of the seventh session of UNCTAD and the structural framework of the medium-term plan, to the demands placed upon it at the seventh session. They relate to the responsibilities involved in carrying out the specific tasks assigned to the secretariat by the Final Act of the seventh session of UNCTAD. The broader task of revitalizing and recrienting the overall work programme of UNCTAD to respon to current and foreseen demands, including concomitant deployment of resources, taking account of the new emphasis and orientations provided by the Final Act of the seventh session will require more time. It will be guided by the evaluations of the seventh session currently under way in Governments and in the secretariat, as well as by the comprehensive processes of reform in progress within the United Nations as a whole. Action to these ends will be pursued in the coming months in conjunction with the forthcoming preparation of the next medium-term plan.
- 6. The secretariat is expected to meet these demands in a climate of financial stringency and growing resource constraints. It is therefore compelled to intensify its efforts to deploy available resources to the maximum effect in pursuit of the objectives and mandates of UNCTAD. In the first instance, ir order

to maintain the level of substantive activities, arrangements are under way for the streamlining of administrative functions including those relating to the management of technical co-operation and for the modification of arrangements for meetings servicing. The Secretary-General is also reviewing the possibility of streamlining and enhancing the functions of Executive Direction and Management.

7. As a response to decisions taken at the seventh quadrennial session of the United Nations Conference on Trade and Development, the Secretary-General recommends that the General Assembly approve the following revision to the proposed programme budget for the biennium 1988-1989 (A/42/6 (Sect. 15)).

Output: Technical publications: (a) case studies on short, medium— and long-term effects of national structural adjustment policies on economic performance and growth and on the achievement of social objectives; (b) analysis of economic performance in and constraints faced by least developed countries; (c) export potentials; (d) diversification of exports in terms of both products and destination; (e) import cost—saving measures; (f) the role of the enterprises sector in least developed countries, including appropriate incentive systems (third and fourth quarters, 1988 and 1989).

In addition, substantive support will be provided to short-term advisory missions and seminars.

1.5 Evaluation of financial flows and technical assistance, and analysis of aid conditions and absorptive capacity

Output: Reports to the Trade and Development Board and the Intergovernmental Group on the Least Developed Countries containing (a) evaluations of external financial flows to the least developed countries including the potential for expanding such flows and (b) analyses of aid conditions, terms and modalities as applied to the least developed countries as well as ways of strengthening aid effectiveness (third quarters, 1988 and 1989).

In addition, it is planned to help the least developed countries to identify the technical assistance available multilaterally and bilaterally to improve their planning and administrative capacity.

- II. PREPARATORY WORK FOR BRINGING THE COMMON FUND FOR COMMODITIES INTO OPERATION
- 8. The Agreement Establishing the Common Fund for Commodities was adopted by the United Nations Negotiating Conference on the Common Fund at its fourth session on 27 June 1980. During that session, the Negotiating Conference also adopted a resolution establishing a preparatory commission. That resolution, inter alia, called on the Secretary-General of UNCTAD, after consultation with the Chairman of the Preparatory Commission, to establish a special unit for the servicing of the Commission. The Negotiating Conference also decided that, pursuant to General Assembly decision 34/446, the expenses incurred by the work of the Preparatory Commission and the Special Unit, with the exclusion of expenses incurred by members of and participants in the Commission in attending its meeting, might be met from the funds advanced by the General Assembly, which would be repaid by the Fund as soon as possible after the entry into force of the Agreement.
- 9. In its resolution 35/226 A of 17 December 1980, the General Assembly appropriated an amount of \$1,750,500 under section 15, UNCTAD, of the programme budget for the biennium 1980-1981 to finance an advance required for the preparatory work for bringing the Common Fund into operation. The Assembly, in resolution 35/226 B, also approved an estimate of income in the same amount under income section 2, General income, of the 1980-1981 programme budget, reflecting the reimbursement due to the United Nations from the Common Fund upon its entry into force. The arrangement was extended by General Assembly resolutions 36/240 A and B to the biennium 1982-1983 and by Assembly resolutions 38/236 A and B to the biennium 1984-1985.
- 10. At its fortieth session, the General Assembly considered a note by the Secretary-General contained in document A/C.5/40/79 and, by its resolution 40/253 A, appropriated an amount of \$942,000 under section 15 of the programme budget for the biennium 1986-1987, which represented the unspent balance of the advance of \$1,750,500 that it had approved under the 1980-1981 programme budget. By resolution 40/253 B, the Assembly also approved an amount of \$1,750,500 under income section 2 of the programme budget for the biennium 1986-1987, representing the reimbursement for expenditures of \$808,500 incurred against the advance in the bienniums 1980-1981 and 1982-1983 and the appropriation of \$942,200 made for the biennium 1986-1987.
- 11. No expenditures were incurred in the biennium 1986-1987 from the advance of \$942,000 appropriated. The Preparatory Commission did not meet during the biennium, and its substantive work was held in abeyance since the conditions for entry into force of the Agreement were not met. This unspent amount of \$942,000 is being surrendered in the context of the second performance report on the programme budget for the biennium 1986-1987.
- 12. For the Agreement Establishing the Common Fund for Commodities to enter into force, it must be signed and ratified, accepted or approved by at least 90 States, whose total subscriptions of shares of directly contributed capital must be equivalent to not less than two thirds of the total subscriptions of shares of directly contributed capital allocated to all States specified in schedule A to the

Agreement. At the conclusion of the seventh session of UNCTAD, 95 States had ratified the Articles of Agreement accounting for 59.39 per cent of the directly contributed capital and a further 7 States accounting for a total of 7.56 per cent of directly contributed capital indicated their intention to do so before the end of 1987. Consequently, it is confidently expected that the conditions for entry into force of the Agreement will be met by the end of 1987 and that the meetings of the Preparatory Commission originally foreseen for 1986-1987 will be held in 1988. In order to service these meetings and to provide such support as the Fund may require pending receipt of the subscriptions of members of the Common Fund, it is estimated that the unspent balance of the advance of \$1,750,500 amounting to \$942,000 would be required in the biennium 1988-1989.

13. The Secretary-General, therefore, recommends that the General Assembly approve the following revised estimates to the proposed programme budget for the biennium 1988-1989 in the light of developments in bringing the Common Fund into operation.

The provision of \$942,000 in the 1988-1989 budget of section 15, UNCTAD, together with the expenditures in the bienniums 1980-1981 and 1982-1983 of \$808,500, would be fully offset by an amount of \$1,750,500 under income section 2 of the 1988-1989 programme budget, representing the reimbursement due the United Nations from the Common Fund once the Agreement enters into force. Such reimbursement will have first claim against the revenues of the Common Fund. Provision for staff assessment estimated at \$49,700 would also be required under section 31, offset by a corresponding amount in income section 1 of the 1988-1989 programme budget.
