Note dated 29 April 1992 from the Ministry of Foreign Affairs of Nicaragua addressed to the Secretary-General

The Ministry of Foreign Affairs of the Republic of Nicaragua has the honour to inform the Secretary-General of the United Nations that, the deadline of 15 April 1992 having expired. Nicaragua undertakes to comply fully with all the provisions of Security Council resolution 748 (1992) of 31 March 1992. In that connection, it wishes to inform him of the following:

There is no air traffic of any kind to or from the territory of Nicaragua and there are no overflights by any aircraft which is destined to land in or has taken off from the territory of Libya.

In keeping with its policy with regard to reconciliation and disarmament, Nicaragua has no arms industry. Accordingly, no technical advice, assistance or training related to the provision, manufacture, maintenance, or use of arms and related material of all types is provided to Libya by its nationals or from its territory.

Nicaragua will not permit, by its nationals or from its territory, the supply of aircraft or aircraft components to Libya or the provision of engineering and maintenance servicing of Libyan aircraft or new insurance claims or contracts for Libyan aircraft.

The Government of Nicaragua has decided to reduce the number of members of the staff of the Libyan diplomatic mission from four to three.

Similarly, the Government of Nicaragua reports that it has take: the necessary measures to control and restrict the movement of the staff remaining in Nicaragua to a radius of 30 kilometres from the diplomatic mission.

Nicaragua will continue to support any regional and international measures which the Sacurity Council and the Sacuraty-General of the United Nations may take to bring about the peaceful settlement of disputes between States.
