Note verbale dated 1 May 1992 from the Permanent Representative of Portugal to the United Nations addressed to the Secretary-General

The Permanent Representative of Portugal to the United Nations presents his compliments to the Secretary-General of the United Nations and, with reference to the note dated 16 March 1992, has the honour to kindly call his attention to the information provided by the Mission in its note dated 28 March 1991 (A/46/131), as required by Article 73 g of the Charter, the terms of which remain valid.

As it has been widely reported, the situation prevailing in the Non-Self-Governing Territory of East Timor under Portuguese administration was seriously and further aggravated when Indonesian military, which have been illegally occupying East Timor since 7 December 1975, opened fire indiscriminately on a crowd of East Timorese unarmed civilians gathered near the Santa Cruz cemetery in Dili, on 12 November 1991. Hundreds of people were killed or wounded and many dozens are still unaccounted for.

This unacceptable violence prompted a generalized outcry throughout the world. A number of official United Nations documents were circulated regarding the event and its aftermath, including a report issued by the Special Rapporteur on Torture of the Human Rights Commission, who was then visiting the Territory.
