II. REPORTS AND VIEWS RECEIVED FROM STATES

- A. Reports received from States pursuant to paragraph 9 of General Assembly resolution 41/78
- 1. Note verbale from the Permanent Mission of Chile to the United Nations addressed to the Secretary-General

(Original: Spanish)

[17 September 1987]

The Permanent Mission of Chile transmitted the following information.

Serious violations of the protection and security of our diplomatic missions abroad

(July 1986-July 1987)

I.

1. Time, date and location of the reported violation

10.15 a.m., on 3 July 1986, consular office.

2. Characteristics of the reported violation

It was occupied by a group of about 35 persons who broke in during a protest demonstration in front of the Consulate.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Hamburg, Federal Republic of Germany.

4. Casualties sustained and damage caused by the reported violation

Disturbances and disorder in various rooms; they used the tetephones and tried to transmit a protest message by telex to the Ministry of the Interior of Chile.

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Mostly of German nationality.

6. Devices and means used for carrying out the reported violation

In order to effect entry, they took advantage of the confusion caused by a protest that was under way in front of the building.

7. Accomplices of the alleged of fender (s)

Demonstrators from the Civil Assembly (about a hundred persons).

- 8. Measures taken to apprehend and to bring the alleged offender to justice
 The assistance of the forces of law and order (police) was requested.
- 9. Final outcome of the proceedings against the offender

 Following the occupation, the police proceeded to identify the demonstrators.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed
- 11. Measures adopted with a view to preventing a repetition of the reported violation

Once the details had been ascertained, a protest note was addressed to the Senate of Hamburg and a number of meetings were held with members of the plain-clothed and uniformed police.

Morning of 11 September 1986, facade of the consular office.

2. Characteristics of the reported violation

Throwing of paint.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Munich, Federal Republic of Germany.

- 4. Casualties sustained and damage caused by the reported violation
 Paint splashes on the façade, coat-of-arms, windows and pavement.
- 5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unidentified elements.

- 6. Devices and means used for carrying out the reported violation

 Five bags containing red paint.
- 7. Accomplices of the alleged offender (s)
- 3. Measures taken to apprehend and to bring the alleged offender to justice
 The police were notified.
- 9. Final outcome of the proceedings against the offender
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

The police authorities were requested to step up their vigilance as a precaution against any further such acts.

12. Other relevant information

This incident followed a series of acts against the consular and diplomatic missions of Chile in the Pederal Republic of Germany during the week of 8 to 12 September 1986. (Embassy of Chile, Bonn; Consulate-General, Hamburg; Consulate-General, Frankfurt.)

 The writing of political slogans against the Government of Chile.

- 4. Casualties sustained and damage caused by the reported violation Streaks of paint.
- 5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unknown.

- 6. Devices and means used for carrying out the reported violation
 Paint.
- 7. Accomplices of the alleged offender(s)
 Unknown.
- 8. Measures taken to apprehend and to bring the alleged offender to justice
 The police were informed.
- 9. Final outcome of the proceedings against the offender Unknown.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) sommitted

The police authorities were requested to provide the necessary vigilance.

12. Other relevant information

 - 11 September 1986, offices of the Consulate.
- 2. Characteristics of the reported violation

Following a political demonstration in front of the offices of the Consulate, one demonstrator threw a bag of paint and others wrote political slogans.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Salta, Argentina.

4. Casualties sustained and damage caused by the reported violation

Paint splashes on the façade of the Consulate and political slogans written on the road surface.

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

A political group calling itself "Democratic Chile".

- 6. Devices and means used for carrying out the reported violation
 Bag of paint.
- 7. Accomplices of the alleged offender (s)

Demonstrators.

- 8. Measures taken to apprehend and to bring the alleged offender to justice

 Members of the police were present (they remained passive).
- 9. Final outcome of the proceedings against the offender Unknown.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

None, since the offenders committed the act without warning, taking advantage of a protest demonstration under way against the Government of Chile.

7.40 p.m., on 5 May 1987, by the rear wall of the Embassy.

2. Characteristics of the reported violation

The placing of an explosive device.

3. Mission(s) or representative(s) against whom the reported violation was directed

Embassy of Chile in Argentina.

- 4. Casualties sustained and damage caused by the reported violation
- 5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unknown.

6. Devices and means used for carrying out the reported violation

Explosive device with a timing mechanism.

- 7. Accomplices of the alleged offender (s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice

 The police were informed.
- 9. Final outcome of the proceedings against the offender
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

The authorities (Argentine Foreign M_nistry) were informed and were requested to ensure a redoubling of the vigilance and security that should be provided by the police, who had been forewarned, having received an anonymous telephone call announcing the placing of the explosive device.

The explosive device failed to detonate, owing to dampness in its components.

On the rear wall of the Embassy, unknown persons painted slogans alluding to exile and condemning the Government of Chile.

Embassy of Chile in Argentina.

 - Paint daubed on the wall.
- 5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unknown.

- 6. Devices and means used for carrying out the reported violation Paint.
- 7. Accomplices of the alleged offender (a)
- 8. Measures taken to apprehend and to bring the alleged offender to justice
 The police were informed.

The Argentine authorities were once again informed of the need to ensure adequate police protection.

Unknown.

- 6. Devices and means used for carrying out the reported violation

 The placing and detonation of an explosive device.
- 7. Accomplices of the alleged offender (s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice

 The details were communicated to the police.
- 9. Final outcome of the proceedings against the offender
 The local police took charge of the investigation.

Fortunately the explosion caused only material damage, there being no victims.

6 p.m., on 11 September 1986, façade of the building.

2. Characteristics of the reported violation

At the conclusion of an "ecumenical prayer meeting" in front of the Consulate, a group of participants wrote slogans opposing the Government of Chile.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Rio de Janeiro, Brazil.

4. Casualties sustained and damage caused by the reported violation

Paint on the door and the façade of the building.

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unknown.

6. Devices and means used for carrying out the reported violation

Paint.

7. Accomplices of the alleged offender (s)

Representatives of various churches.

- 8. Measures taken to apprehend and to bring the alleged offender to just ice
- 9. Final outcome of the proceedings against the offender
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

The police were informed.

12. Other relevant information

IX.

- 1. Time, date and location of the reported violation
 - 11 a.m., on 10 July 1987, reception hall.
- 2. Characteristics of the reported violation

A group of 12 Chileans and a photographer forced their way into the reception hall of the Consulate, occupying that part of the premises; they unfurled Chilean flags and banners bearing slogans opposed to the Government of Chile.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in São Paulo, Brazil.

- 4. Casualties sustained and damage caused by the reported violation
 - The permanent guard was assaulted and paint was daubed on walls.
- 5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Unidentified Chileans living in Brazil.

6. Devices and means used for carrying out the reported violation

Flags, banners and paint.

7. Accomplices of the alleged offender (8)

A photographer (nationality unknown).

- 8. Measures taken to apprehend and to bring the alleged offender to justice

 The police were informed.
- 9. Final outcome of the proceedings against the offender
 Unknown.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

12. Other relevant information

After 25 minutes, the group was removed from the Consulate by the federal police in order to make statements concerning the incident.

- 1. Time, date and location of the reported violation
 - 10.30 a.m., on 17 July 1986, consular of ice.
- 2. Characteristics of the reported violation

Occupation.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Madrid, Spain.

4. Casualties sustained and damage caused by the reported violation

They confined themselves to shouting slogars against the Government of Chile without causing damage to the building.

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Seventeen young Spaniards belonging to communist youth movements.

- 6. Devices and means used for carrying out the reported violation
- 7. Accomplices of the alleged offender (s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice

 The police were informed.
- 9. Final outcome of the proceedings against the offender Unknown.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

12. Other relevant information

This occupation occurred at the same time as the occupation of the Consulate-General of Chile in Barcelona (date - time - perpetrators).

XI.

1. Time, date and location of the reported violation

10.30 a.m., on 17 July 1986, entrance hall of the Consulate.

Characteristics of the reported violation

Just as the door had been opened to permit a person to leave, a group of 17 persons gained entry to the entrance hall of the Consulate and shouted political slogans opposing the Government of Chile.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Barcelona, Spain.

- 4. Casualties sustained and damage caused by the reported violation
- Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Spaniards.

- 6. Devices and means used for carrying out the reported violation
- Accomplices of the alleged offender(s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice

The occupants were removed by members of the police force, who took five of them into custody to await charges.

9. Final outcome of the proceedings against the offender

Unknown.

10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

Permanent police protection for the Consulate was requested.

12. Other relevant information

The group consisted of very young elements, apparently belonging to Spanish communist youth movements; the incident occurred simultaneously with a similar act at the Consulate-General of Chile in Madrid. Our Consulate in Barcelona had already been occupied on 22 April 1986, when the same tactics had been used.

XII.

- 1. Time, date and location of the reported violation
 - 9 September 1986, offices of the Consulate.
- 2. Characteristics of the reported violation

Occupation by a group of 30 persons.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Madrid, Spain.

4. Casualties sustained and damage caused by the reported violation

It lasted approximately three hours, during which they shouted slogans against the Government of Chile and made telephone calls to various foreign radio stations informing them of the occupation.

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Members of Spanish communist youth movements.

- 6. Devices and means used for carrying out the reported violation
 They took advantage of another person's entry.
- 7. Accomplices of the alleged offender(s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice
 They were taken into custody by the police.
- 9. Final outcome of the proceedings against the offender Unknown.
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

Details were communicated to the Foreign Ministry, and the innumerable requests for security at the diplomatic missions of Chile in Spain were reiterated.

12. Other relevant information

During the occupation, the perpetrators indicated that their action was co-ordinated with that of other communist groups which would be occupying consulates. This Consulate had been occupied on 17 July 1986. The same occupants had permitted the entry of television personnel and the reading of a communiqué. Also on that date and at the same time, the Honorary Consulate of Chile in San Sebastian, Spain, had been occupied.

XIII.

 - 10.30 a.m., on 9 September 1986, offices of the Consulate.
- 2. Characteristics of the reported violation

Attempted occupation.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Barcelona, Spain.

4. Casualties sustained and damage caused by the reported violation

During the attempted occupation, they shouted communist slogans and insults against the Chilean authorities; they also proceeded to paint offensive slogans on the exterior walls.

Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

A group of 30 persons belonging to Spanish communist youth movements.

6. Devices and means used for carrying out the reported violation

They took advantage of a person's authorized entry in order to gain entry to the offices of the Consulate.

- 7. Accomplices of the alleged offender(s)
- 8. Measures taken to apprehend and to bring the alleged offender to justice

 The police were very slow in taking action.
- 9. Final outcome of the proceedings against the offender
- 10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

Adequate police protection was requested.

12. Other relevant information

This Consulate had already been occupied on 17 July 1986. The occupation was finally ended by Embassy staff.

11.30 a.m., on 2 April 1987, offices of the Consulate.

2. Characteristics of the reported violation

Occupation (assault) by force.

3. Mission(s) or representative(s) against whom the reported violation was directed

Consulate-General of Chile in Madrid, Spain.

4. Casualties sustained and damage caused by the reported violation

They broke a reinforced door and painted offensive slogans on the walls and stairs.

Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Communist youth of Chile.

6. Devices and means used for carrying out the reported violation

They used heavy benches as battering rams and carried shoe boxes filled with pointed stones.

7. Accomplices of the alleged offender (s)

A band of young Spanish communists.

8. Measures taken to apprehend and to bring the alleged offender to justice

A call was made immediately to the national police and the civil guard.

9. Final outcome of the proceedings against the offender

Two Chileans and nine Spaniards were taken into custody.

10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

Appropriate appeals and protests were made to the Ministry of Foreign Affairs.

12. Other relevant information

This Consulate was occupied by rebellious forces between 17 July 1986 to 5 September 1986.

7 p.m., on 4 July 1986, offices.

2. Characteristics of the reported violation

An attack on the Embassy using paint bombs, spray-guns and tear gas.

3. Mission(s) or representative(s) against whom the reported violation was directed

Embassy of Chile in France.

4. Casualties sustained and damage caused by the reported violation

5. Name, nationality, place of habitual or permanent residence of the alleged offender(s) and other available information regarding the identity of such offender(s)

Six unidentified persons.

6. Devices and means used for carrying out the reported violation
Paint, spray-guns and tear gas.

7. Accomplices of the alleged offender(s)

8. Measures taken to apprehend and to bring the alleged offender o justice

9. Final outcome of the proceedings against the offender

10. Assistance of other States directly concerned in connection with the proceedings brought in respect of the offence(s) committed

Three days prior to the incident, a request had been made in writing for a police guard to be stationed at the Embassy.

The perpetrators threw tear gas to prevent the staff from leaving the building.

No damage reported.

Ten unidentified persons.

 Force.

Destruction of the vehicle.
