NOTE VERBALE DATED 22 JUNE 1992 FROM THE PERMANENT REPRESENTATIVE OF TURKEY TO THE UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

The Permanent Representative of Turkey to the United Nations presents his compliments to the Secretary-General of the United Nations and with reference to his note dated 3 June 1992 has the honour to enclose herewith the list of measures instituted by the Turkish Government for meeting the obligations set out in paragraphs 4 to 9 of Security Council resolution 757 (1992) (see annex).

Measures taken by the Republic of Turkey in implementation of Security Council resolution 757 (1992)

1. Security Council resolution 757 (1992) was published in the Turkish Official Gazette of 2 June 1992 whereupon it was put into force.

2. The import into Turkey of any product originating in the Federal Republic of Yugoslavia (Serbia and Montenegro) is not permitted. Any non-Turkish toad transport & shicle carrying products originating in the Federal Republic of Yugoslavia (Serbia and Montenegro) and loaded after 30 May 1992 will not be permitted to enter Turkey. Turkish road transport vehicles, in such cases, will enter Turkey but their consignment will be kept under customs control.

3. Any product originating in the Federal Republic of Yugoslavia (Serbia and Montenegro) and exported therefrom will not be loaded or unloaded in Turkish ports whethe: for transshipment purposes or not.

4. All exports from Turkey to the Federal Republic of Yugoslavia (Serbia and Montenegro) shall be subject to government permission. Export permission shall be granted only for those supplies intended for medical purposes and foodstuffs, notified to the Security Council Committee established by resolution 724 (1991).

5. All transfer of funds to and from persons or institutions in the Federal Republic of Yugoslavia (Serbia and Montenegro) have been suspended, except payments for medical or humanitarian purposes and foodstuffs, which shall be remitted upon acquiring permission of the Central Bank of the Republic of Turkey. All funds and resources due to persons or institutions in the Federal Republic of Yugoslavia (Serbia and Montenegro) in accordance with international agreements and contracts shall be blocked in an account of the Central Bank of the Republic of Turkey.

6. Landing, take-off or overflight permission shall not be granted to any aircraft destined to the Federal Republic of Yugoslavia (Serbia and Montenegro) or originating there, with the exception of flights carrying humanitarian aid, medical supplies or foodstuffs, approved by the Security Council Committee established by resolution 724 (1991).

7. Participation in sporting events in Turkey of persons or groups representing the Federal Republic of Yugoslavia (Serbia and Montenegro) has been suspended.

8. Scientific and technical cooperation and cultural exchanges and visits between Turkey and the Federal Republic of Yugoslavia (Serbia and Montenegro) have been suspended.
