- 1. The CHAIRMAN said he had been informed that so far no agreement had been reached on the text of the draft resolution on item 53. He hoped that a draft resolution would be ready for presentation at the Committee's 35th meeting, so that a statement of its financial implications could be ready for the 36th meeting and a vote could be taken on all the draft resolutions on that item at the 37th meeting at the latest. If he heard no objection, he would take it that the Committee decided to follow that procedure.
- 2. It was so decided.

### ORGANIZATION OF WORK

The CHAIRMAN drew the Committee's attention to a letter of 16 November 1979 addressed to him by the President of the General Assembly (A/SPC/34/1/Add.1) in which he was informed of the General Assembly's decision to allocate to the Special Political Committee an additional item (item 127) entitled "Question of the islands of Glorieuses, Juan de Nova, Europa and Bassas da India" whose inclusion in the agenda had been requested by the Permanent Representative of Madagascar. He hoped that the representative of Madagascar would be in a position to introduce that item at the Committee's meeting on Monday, 26 November. If he heard no objection, he would take it that the Committee decided to follow that procedure.
