JOINT COMMUNIQUÉ

On the Establishment of Diplomatic Relations Between the Hellenic Republic and Saint Kitts and Nevis

The Government of the Hellenic Republic and The Government of Saint Kitts and Nevis:

Desirous to develop and strengthen friendly relations and mutual understanding and cooperation among their two peoples, based on the purposes and principles of the Charter of the United Nations and the norms and principles of International Law,

Convinced that the establishment of diplomatic relations is in the interest of both countries and will contribute to international peace and security,

Have decided to establish diplomatic relations, at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963, as of the date of the signing of this Joint Communiqué.

Done in duplicate, in the English language at New York on the 9th day of July. 2004.
