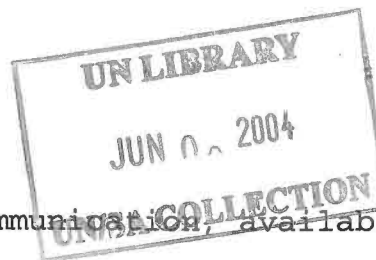

**Joint Communiqué**  
**on**  
**the establishment of Diplomatic Relations between**  
**the Republic of the Sudan and the Union of Myanmar**

The Government of the Republic of the Sudan and the Government of the Union of Myanmar:

*Desirous of* developing mutual understanding and strengthening friendship and cooperation among their two peoples based on the purposes and principles of the Charter of the United Nations and of international law;

*Convinced* that the establishment of diplomatic relations is in the interest of both States and would contribute to the consolidation of peace;

*Have decided* to establish diplomatic relations, at the ambassadorial level, in accordance with the provisions of Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963, as of the date of the signing of this Joint Communiqué.
