


Excellency,

We kindly request Your Excellency to have the text of this letter and the enclosed Protocol circulated as a United Nations document.



**PROTOCOL**

**ON THE ESTABLISHMENT OF  
DIPLOMATIC RELATIONS BETWEEN  
THE REPUBLIC OF ARMENIA AND THE REPUBLIC OF RWANDA**

The Republic of Armenia and the Republic of Rwanda,

Desirous to promote mutual understanding and to strengthen the relations of friendship and cooperation among their two peoples,


Determined to develop these relations guided by the principles of the Charter of the United Nations and international law,

Have decided to establish diplomatic relations at Ambassadorial level, as of the date of signing of this Protocol, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.

In witness whereof, the undersigned representatives, duly authorised by their respective Governments, have signed this Protocol in three originals in Armenian, French and English languages, all texts being equally authentic.

Done in New York, on 29 March 2004.



**RELATIF À L'ETABLISSEMENT

Désireux de promouvoir une entente mutuelle et de renforcer des relations amicales et de coopération entre leurs peuples respectifs,


Déterminés à développer ces relations, guidés par les principes de la Charte des Nations Unies et du Droit International,
