JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE REPUBLIC OF THE SUDAN
AND
THE REPUBLIC OF SINGAPORE

The Government of the Republic of the Sudan and the Republic of Singapore: desirous of strengthening the existing friendly relations between their governments and peoples; and promoting and intensifying their co-operation, in the political, economic, social and cultural fields in accordance with the principles of international co-operation as reflected in the United Nations Charter; have decided to establish diplomatic relations at the Ambassadorial level.
