JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF CAMEROON AND THE DEMOCRATIC REPUBLIC OF TIMOR-LESTE

The Government of the Republic of Cameroon and the Government of the Democratic Republic of Timor-Leste:

Desirous:

1/ to sustain and to strengthen the friendly relations between their two countries in the mutual interest of their peoples;

2/ to promote and to intensify cooperation between their respective countries, in the political, economic and cultural domain;

On the basis of their common adherence to the principles of international law, the goals and objectives of the United Nations Organisation as regards to the need to preserve international peace and security, and to eliminate all forms of discrimination;
