AGREEMENT

BETWEEN THE REPUBLIC OF SLOVENIA AND THE DEMOCRATIC REPUBLIC OF TIMOR-LESTE CONCERNING THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

The Republic of Slovenia and the Democratic Republic of Timor-Leste, guided by a desire to strengthen and develop relations between the two countries in accordance with the purposes and principles of the Charter of the United Nations,

Have agreed as follows:

Article 1

The Republic of Slovenia and the Democratic Republic of Timor-Leste shall establish diplomatic relations at the ambassadorial level on the day this Agreement enters into force.

Article 2

The Parties to this Agreement agree that the provisions of the Vienna Convention of Diplomatic Relations of 18 April 1961 shall apply to the diplomatic relations between them.

Article 3

The Parties to this Agreement agree that the provisions of the Vienna Convention of Consular Relations of 24 April 1963 shall apply to the consular relations between them.

Article 4

This Agreement enters into force on the date of signature.
