## JOINT COMMUNIQUE ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF ANGOLA AND REPUBLIC OF UZBEKISTAN

The Republic of Angola and the Republic of Uzbekistan,

Confirming mutual recognition of principles of independence, sovereignty, territorial integrity and non-interference in internal affairs of each other,

Wishing to develop bilateral political, economic and cultural cooperation,

Confirming adherence to the principles of United Nations Organization's Charter and other universally recognized international laws,

In accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963,

Have agreed to establish diplomatic relations between the two states as of the date of the signing of this Joint Communique.
