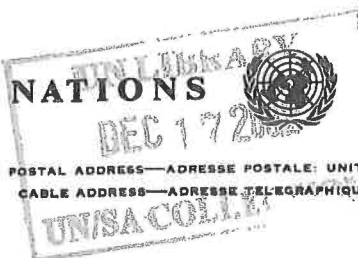

Excellency,



We have the honour, further, to kindly request Your Excellency to transmit this information, with the enclosed Protocol, to the Permanent Missions of all Member States of the United Nations.

**ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE REPUBLIC OF SEYCHELLES
AND
THE STATE OF ERITREA**

The Government of the Republic of Seychelles and the Government of the State of Eritrea, guided by shared willingness to develop ties of friendship and cooperation in the political, economic, cultural, humanitarian and other fields, have decided to establish relations.

The Government of the Republic of Seychelles and the Government of the State of Eritrea hereby agree to the establishment of diplomatic relations between their two countries as of the date of this Note based on the Vienna Convention on Diplomatic Relations of 18 April 1961 and on the principles and norms of the Charter of the United Nations and of international law.

The Government of the Republic of Seychelles and the Government of the State of Eritrea are fully convinced that the establishment of diplomatic relations corresponds to the interests of both States and will further strengthen international peace and security.


