**JOINT COMMUNIQUE  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE REPUBLIC OF BELARUS  
AND THE REPUBLIC OF SEYCHELLES**

The Republic of Belarus and the Republic of Seychelles,

With the purpose to promote mutual understanding and strengthen the friendship and cooperation among their Peoples,

On the basis of the principles and purposes of the Charter of the United Nations and international law, particularly on international peace and security, equality among States, respect for national sovereignty, independence, international treaties, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in duplicate in Belarusian, French and English, all texts being equally authentic.

**COMMUNIQUE CONJOINT SUR  
L'ETABLISSEMENT DES RELATIONS DIPLOMATIQUES  
ENTRE

La République du Bélarus et la République des Seychelles,

Dans le but de promouvoir la compréhension mutuelle et de consolider l'amitié et la coopération parmi leurs peuples,

Sur la base des principes et des objectifs de la Charte des Nations Unies et du Droit international, en particulier relatif à la paix et la sécurité internationale, à l'égalité entre les Etats, au respect de la souveraineté nationale, à l'indépendance, aux traités internationaux, à l'intégrité territoriale et la non-ingérence dans les affaires intérieures des Etats,

Ont décidé d'établir les relations diplomatiques conformément aux dispositions de la Convention de Vienne sur les relations diplomatiques du 18 avril 1961, à compter de la date de la signature de ce présent Communiqué Conjoint.

En foi de quoi, les Plénipotentiaires ci-dessous de leurs Gouvernements respectifs, ont signé le présent Communiqué en double exemplaire, en bélarusien, français et anglais, tous les textes ayant la même authenticité.
