Subject: SALARY AND WAGE ADMINISTRATION PLAN

1. Purpose

The attached salary schedule replaces the salary schedule for staff members employed on annual salaries as set forth in SGB/19, 3 May 1946, "Provisional Salary and Wage Administration Plan", effective 16 June 1947. IC/70, 18 June 1946, "Computation of Salary Payments", and IC/220, 15 November 1946, "Identification of Grades of the United Nations Salary Schedule", are hereby superseded.

Included in the attached schedule, for purposes of convenient reference, are the rates for compensation of hourly paid staff members, as established in SGB/19/Add.7, 18 March 1947.

2. Changes over Old Plan

All annual salaries up to and including \$5550 under the plan established by SGB/19 are increased by \$200 a year; salaries between \$5900 and \$8700, inclusive, are increased by lesser amounts.

The number of steps within Grades 1 through 14 has been increased from five to seven, in grades 15 and 16, from four to seven, in Grade 17, from four to six. Grades 18 and 19 remain unchanged with four and three steps respectively.

Within-grade salary increases will be granted to salaried staff members in accordance with the provisions of SGB/53/Rev.1, June 1947, "Within-Grade Salary Increases".

3. Applicability of Salary Scale

The attached schedule will apply to salaried staff members inside the classification plan in all United Nations offices, increased or decreased in accordance with the differentials which may be established from time to time for offices away from Headquarters.
