> STATISTICAL DATA AND OTHER INFORMATION SUBMITTED BY MEMBER STATES IN CONNEXION WITH THE REVISION OF THE UNITED NATIONS SCALE OF ASSESSMENTS

> > Report by the Secretary-General

1. At the eighth session of the General Assembly, it was decided in the Fifth Committee that Member States should be informed of the dates of the meetings of the Committee on Contributions as soon as they had been fixed. This arrangement was made in order to enable Governments to make available the latest estimates of national income and other relevant data in time for the Committee to take such information into account in the formulation of its recommendations to the General Assembly on the scale of assessments.

2. On 9 May 1958, the Secretary-General informed Member States that the next session of the Committee on Contributions would open in New York on 5 August and was expected to last for about two weeks. It was requested that any data relevant to the work of the Committee that Governments might wish to submit should be made available as soon as possible and at the latest by 15 July 1958.

Romania	25 July	Submitted an estimate of the average national income of Romania for 1955-1957. Referring to the statements made at the eleventh session of the General Assembly, formally requests a reduction in the assessment for Romania. For text see Addendum 5.
