## JOINT COMMUNIQUE On the Establishment of Diplomatic Relations Between Ukraine and the Federated States of Micronesia

The Government of Ukraine and the Government of the Federated States of Micronesia,

Desirous of further developing relations of friendship and co-operation between their two countries on the basis of mutual respect for the principles of sovereign equality of States, territorial integrity and non-interference in the internal affairs of other States, in accordance with the Charter of the United Nations,

Intending to develop bilateral co-operation in the political, trade, economic and other fields of interest to both countries,

Have agreed to establish diplomatic relations at the Ambassadorial level as of 17 September 1999.

In witness whereof the undersigned Plenipotentiaries, being duly authorised thereto by their respective Governments, have signed this Joint Communiqué.

Done at New York on this 17<sup>th</sup> day of September, one thousand nine hundred and ninety-nine (1999), in duplicate, each copy in Ukrainian and English languages, both texts being equally authentic.
