JOINT DECLARATION ON THE ESTABLISHMENT OF DIPLOMATIC
RELATIONS BETWEEN THE REPUBLIC OF MALAWI AND THE
HASHEMITE KINGDOM OF JORDAN

The Government of the Republic of Malawi and the Government of the Hashemite Kingdom of Jordan, desirous of promoting and strengthening the already existing friendly relations between the two countries and their peoples and of promoting better ties of understanding and cooperation, guided by the principles of sovereignty and mutual respect have, in accordance with the principles and purposes of the United Nations Charter and the Vienna Convention on Diplomatic Relations of April 18, 1961, decided to establish formal diplomatic relations at the ambassadorial level, from the date of the signing of this Joint Communiqué.
