Sick Prisoners in Ramle Prison Hospital

Al- Ramla prison hospitals located inside Al Ramla prison and is considered one of its sections, it includes eight rooms for Palestinian security prisoners, currently 19 prisoners are languishing in it permanently, who suffers from chronic diseases where it is considered as one of the most dangerous sections in the occupation prisons, as well as some Palestinians who were injured during the Jerusalem Intifada.

Also, there are tens of sick prisoners who are frequented to Ramla prison hospital for days or weeks and then they leave to their prisons again, after being under some medical examinations hen providing them with painkillers.

Prisoners who are Languishing in Al-Ramla hospital do not receive proper treatment for their health and even they are treated like other prisoners in other different prisons in terms of repression , abuse, inspection and confiscation properties, continuous sanctions, and even depriving them from their medication, so that prisoners who have lived in this prison call it "slaughterhouse of Ramla, "where it lacks of the minimum health needs, refusing call it a hospital, because it basically does not provide prisoners with needed health services.

Sick prisoners who are languishing in what called Al-Ramla Hospital are suffering from difficult situation, so they sleep almost 22 hours a day to escape from their suffering and pain, most of them are paralyzed moving on wheelchairs and injured who are subjected to a deliberate medical negligence policy, they are given nothing except painkillers and hypnotics, most of them are living in extreme danger and never get better in this hospital, despite the passage of years since being there.

Al-Ramla prison hospital is ineligible in service or structure, so the prison administration transfers from time to time the sick detainees with critical conditions to be treated in other Israeli hospitals. Moreover, the Israeli occupation authorities deliberately ill the prisoners psychologically and physically, starting with the tragic situation in the hospital to help spreading diseases, through the medical negligence policy, and ending with the malnutrition and deprivation policy deprivation.

The occupation authorities deal with Al-Ramla hospital like any other prison which has any privacy despite the fact that all prisoners are in critical conditions, everything happened in this prison was confirmed by the sick prisoner "Riad Al-Emour," who suffers from heart disease and stayed in the hospital for several years, he said: "The occupation prisons' service proceeded to organize training repression forces (special forces) in Al-Ramla prison hospital departments, those exercises took place in the night hours, where those units stormed the patients' rooms and damaged the sick prisoners' properties for 4 hours every time. Furthermore, the suppression unit, called (Al-Matsada) broke into their rooms, where they continued searching for five hours and when they left, the prisoners were forced to arrange their properties. " The ex-detainee "Akram A-Rakhawi", who stayed 8 years in that hospital, he said that A-Nahshoun unit broke in the hospital department and stripped all prisoners especially hypos padi as patients with polyethylene bag, where they dislodged them while they are naked, unforgettable scene " paralyzed patients, stripped forcibly and brutally, as if you see a terrorist arrest process, where those patients were taken from their rooms to other site with bounded hands and dragged on the floor brutally, those scenes I can't forget.

Prescript wrong medications

The occupation crime against prisoners did not stop at not prescribing medications heals their diseases, but deliberately sometimes they prescribe wrong medications that does not heals the prisoner's disease, so this is why some prisoners suffer from a difficult health problems, including the prisoner: "Khaled Hassan", and Abdallah Al-Qadi (35 years) from Rafah in the southern of Gaza Strip, who was diagnosed with hepatitis disease as a result of giving him wrong medication after what happened with him as a result of being transferred to isolation confinement in May, 2014.
