Please accept, Excellency, the assurances of our highest consideration.

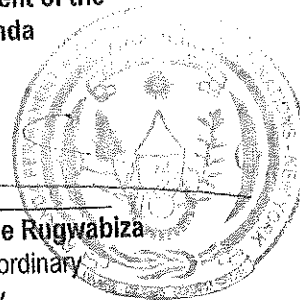

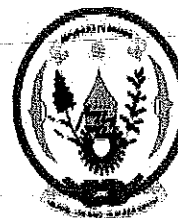

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué.

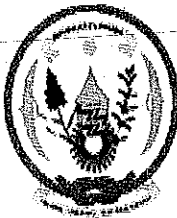

The Government of the Republic of Rwanda and the Government of the Republic of Croatia,


Desirous to promote and strengthen relations of friendship and cooperation between the two countries,
