We have the honour to inform Your Excellency that the Governments of the Union of Myanmar and the Republic of Kenya, in conformity with the interest and desire of the two peoples, have established diplomatic relations between the two countries as of 26 September 1997. The two Governments have agreed to develop friendly relations and cooperation between the two countries on the basis of the five principles of peaceful co-existence and the principles enshrined in the Charter of the United Nations.

It would be appreciated if the text of this letter and the Joint Communique could kindly be circulated as a United Nations document.
