COMMUNICATION FROM SPAIN

The following communication dated 31 March 1977 from the Permanent Mission of Spain to the United Nations addressed to the Secretary-General of the United Nations is submitted to the Committee for its consideration:

"The Permanent Mission of Spain to the United Nations presents its compliments to the Secretary-General of the United Nations and with reference to his note FI 313/1 (1) wishes to inform him that the Spanish Government has decided to send a financial expert who will appear before the Committee on Contributions to explain the statistical data relating to the national income and economic situation of Spain, so that the Committee on Contributions may in due course, with a full knowledge of the facts, revise the assessment approved last year for the Spanish Government.

"In that connexion, the Permanent Mission of Spain would be grateful if the Secretary-General would inform it of the date on which the Committee on Contributions can receive the Spanish expert.

"At the same time, it requests him to transmit this communication to the Chairman of the Committee on Contributions, all of which is without prejudice to Note No. 49 of 29 March 1977, which in accordance with the instructions contained in the aforementioned note of the Secretary-General provided the latter with data concerning the national income of Spain and other relevant information."

For the convenience of the Committee Note No. 49 of 29 March 1977, from the Permanent Mission of Spain to the United Nations addressed to the Secretary-General, is reproduced as an annex.

ANNEX

The Permanent Mission of Spain to the United Nations presents its compliments to the Secretary-General of the United Nations and with reference to his note FI 313/1 (1) of 22 February 1977, requesting information from the Spanish Government in connexion with the next session of the Committee on Contributions, scheduled to open on 4 April 1977 in New York, has the honour to transmit to him below data which will serve as a basis for the possible revision of the scale of assessments for 1977:
