ORGANIZATION OF THE SESSION

Note by the Secretariat

- 1. The fifty-second session of the Committee on Contributions will be held in New York from 15 June to 2 July 1992.
- 2. Simultaneous interpretation will be provided from and into Chinese, English, French, Russian and Spanish.
- 3. In accordance with past decisions of the Committee, there will be no minutes or sound recording of the proceedings. The only published document will be the Committee's report to the General Assembly at its forty-seventh session.
- 4. A list of documents and a draft timetable for the session are contained in annexes I and II to the present document, respectively.
- 5. In order to ensure efficient utilization of the conference-servicing resources available to the Committee, the following procedures will be observed:
- (a) <u>Duration of meetings</u>. Morning meetings will be held from 10.30 a.m. to 1 p.m. and afternoon meetings from 3 to 6 p.m. For the extension of any meeting up to 30 minutes beyond those hours, the approval of the Chief of the Interpretation Service will be obtained;
- (b) <u>Informal meetings</u>. If the Committee decides to hold informal meetings requiring conference-servicing facilities, the conference room officer will be consulted prior to the formal announcement of the date and place of such meetings;
- (c) <u>Weekly summary</u>. Each week, the Secretary of the Committee will provide the Office of Conference Services with a summary of meetings containing information on the number of meetings held and cancelled and the time lost as a result of meetings starting late or ending early.
