

Excellency,



JOINT DECLARATION

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN BARBADOS AND THE REPUBLIC OF POLAND

The Government of Barbados and the Government of the Republic of Poland desirous of developing and strengthening relations between the two countries in the interest of peace and cooperation among peoples and on the basis of mutual respect for independence, sovereignty and territorial integrity, as well as on the principles of non-interference, non-use of force in international relations, peaceful settlement of disputes and other principles enshrined in the Charter of the United Nations, have agreed to establish diplomatic relations between the two countries at ambassadorial level and designate, as a first step, ambassadors on a non-resident basis.

Done at New York, on 13 September 1996


