#### **PROTOCOL**

## on the establishment of diplomatic relations between THE REPUBLIC OF FIJI and the REPUBLIC OF URUGUAY

The Republic of Fiji and the Republic of Uruguay, guided by a mutual willingness to develop relations of friendship and cooperation between the two countries in political, trade, economic and other fields, have decided to establish diplomatic relations as of the date of signing of this Protocol in accordance with the Vienna Convention on Diplomatic Relations signed on April 18, 1961.

The two sides have reached an agreement to develop their relations on the basis of principles of equality of states, mutual respect, self-determination, independence and sovereignty, territorial integrity and non-interference into internal affairs of each other in accordance with the United Nations Charter.

Both sides are convinced that the establishment of diplomatic relations between the REPUBLIC OF FIJI and the REPUBLIC OF URUGUAY correspond to the interests of the two States, is not directed against any other country and will facilitate strengthening of international cooperation and universal peace.

### JOINT STATEMENT

The Government of the Republic of Fiji and the Government of the Republic of Uruguay in accordance with the interests and desires of both peoples have decided to establish diplomatic relations at ambassadorial level as for September 17th., 1996.

Both Governments have agreed to develop the friendly relations existing between the two countries based on the principles of mutual respect of their sovereignty and territorial integrity, non aggression, non intervention in the internal affairs, equality and mutual benefit and pacific coexistence.

The Government of the Republic of Fiji and the Government of the Republic of Uruguay have agreed to exchange non resident ambassadors in accordance with international law and practice.

For that purpose, the duly authorized Representatives of the Republic of Fiji and the Republic of Uruguay have signed this protocol in duplicate, in the English language, the text of which is authentic.

### COMUNICADO CONJUNTO

El Gobierno de la República de Fiji y el Gobierno de la República del Uruguay, en conformidad con los intereses y los deseos de los dos pueblos, han decidido establecer relaciones diplomáticas a nivel de Embajador, a partir de la fecha.

Los dos Gobiernos han convenido en desarrollar las relaciones amistosas entre los dos países sobre la base de los principios de respeto recíproco a la soberanía y la integridad territorial, no agresión, no intervención en los asuntos internos de un país por parte de otro, igualdad y beneficio mutuo y coexistencia pacífica.

A tales fines, el Gobierno de la República de Fiji y el Gobierno de la República del Uruguay han convenido, asimismo, como fase inicial de estas relaciones internacionales, designar Embajadores concurrentes.
