
We take this opportunity to renew to your Excellency the assurances of our highest consideration.

**JOINT COMMUNIQUE**  
**on the establishment of diplomatic relations between**  
**the Azerbaijan Republic and the Republic of Bolivia**

The Government of the Azerbaijan Republic and the Government of the Republic of Bolivia, guided by the principles of the Charter of the United Nations, and desirous of promoting a spirit of mutual understanding and strengthening relations of friendship and cooperation existing between the peoples of two countries,

Have decided to establish diplomatic relations, as of the date of the signing of this Joint Communique at Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Communique, in triplicate, in Azerbaijani, Spanish and English languages, all texts being equally authentic.






