

**JOINT COMMUNIQUE  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN THE REPUBLIC OF BOLIVIA AND THE REPUBLIC OF MOLDOVA**


The Governments of the Republic of Bolivia and the Republic of Moldova, in accordance with the Principles and Purposes of the United Nations Charter and the relevant provisions of the Vienna Convention on Diplomatic Relations, have decided to establish diplomatic relations effective July 8, 1996.

The Government of the Republic of Bolivia and the Government of the Republic of Moldova express their confidence that the establishment of diplomatic relations between the two countries will contribute to the strengthening of mutual cooperation in the areas of common interest for the benefit of the peoples of Bolivia and Moldova.

Done at New York, on July 8, 1996 in three equally authentic texts in the Spanish, Romanian and English languages, whereas all three copies have equal force.

**COMUNICADO CONJUNTO  
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS  
ENTRE LA REPUBLICA DE BOLIVIA Y LA REPUBLICA DE MOLDOVA**

Los Gobiernos de la República de Bolivia y la República de Moldova, en concordancia con los Principios y Propósitos de la Carta de las Naciones Unidas y las disposiciones pertinentes de la Convención de Viena sobre Relaciones Diplomáticas, han decidido establecer Relaciones Diplomáticas a partir del 8 de julio de 1996.

El Gobierno de la República de Bolivia y el Gobierno de la República de Moldova expresan su confianza en que el establecimiento de Relaciones Diplomáticas entre ambos países contribuirá al fortalecimiento de la cooperación mútua en las áreas de interés común para el beneficio de los pueblos de Bolivia y Moldova.

Hecho en Nueva York el 8 de Julio de 1996, en tres copias en los idiomas Español, Rumano e Inglés, siendo los textos igualmente válidos.
