

JOINT COMMUNIQUE

on the establishment of diplomatic relations between the
Republic of the Marshall Islands and the Kingdom of Belgium

The Republic of the Marshall Islands and the Kingdom of
Belgium, desirous of promoting and strengthening their
mutual relations,

have decided to establish diplomatic relations at
Ambassadorial level on the basis of the principles of mutual
respect of their sovereignty, equality and non-interference,
as enshrined in the Charter of the United Nations and with
reference to the relevant provisions of the Vienna
Convention of 1961 that regulate diplomatic relations
between states,

The establishment of diplomatic relations comes into
effect on the date of the signing of the present joint
communiqué.

Done in New York on 29 May 1996 in two original copies,
each in the English and French language, the two versions
having equal authenticity.

COMMUNIQUE CONJOINT

Concernant l'établissement des relations diplomatiques entre
la République des Iles Marshall et le Royaume de Belgique

ont décidé d'établir des relations diplomatiques au niveau d'ambassadeur sur la base des principes du respect mutuel de souveraineté, d'égalité et de non-ingérence, tels qu'entérinés dans la Charte des Nations Unies et en accord avec les articles pertinents de la Convention de Vienne de 1961 qui règlent les relations diplomatiques entre les Etats.
