


Excellency,

SAINT VINCENT AND THE GRENADINES


The Government of the Republic of Poland and the Government of Saint Vincent and the Grenadines inspired by their desire to develop friendly relations and cooperation on the basis of mutual respect, national sovereignty, territorial integrity, non-interference and equal rights, based on international law, the Charter of the United Nations and the Vienna Convention on Diplomatic Relations of 18 of April, 1961, have decided to establish diplomatic relations at Ambassadorial level, with effect from the date of signing of this Joint Communiqué.

In witness whereof, the undersigned, being duly authorized thereto, have signed this Joint Communiqué, at New York this 16 day of May in the year one thousand nine hundred and ninety six.
