

COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE
EL ESTADO INDEPENDIENTE DE PAPUA NUEVA GUINEA
Y
LA REPUBLICA DE PANAMA

Los Gobiernos de la República de Panamá y el Estado Independiente de Papua Nueva Guinea, convencidos de que la mejor forma de promover la paz y la seguridad internacionales es a través del entendimiento, cooperación y los vínculos de amistad entre las naciones, han decidido establecer relaciones diplomáticas, a nivel de Embajadores no residentes a partir del 3 de mayo de 1996, de acuerdo con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas de 1961.

Los dos Gobiernos expresan su confianza de que este Acuerdo contribuirá al fortalecimiento de la mutua cooperación en las esferas económicas, comerciales y culturales entre los dos países, quienes comparten los mismos objetivos y metas para promover la paz, la democracia, la justicia y la solidaridad en sus relaciones, de conformidad con los principios y normas del Derecho Internacional.

EN FE DE LO CUAL, los abajo firmantes han suscrito este Comunicado Conjunto en los idiomas español e inglés, siendo ambos textos igualmente auténticos.

JOINT COMMUNIQUE
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE INDEPENDENT STATE OF PAPUA NEW GUINEA
AND
THE REPUBLIC OF PANAMA

The Governments of the Independent State of Papua New Guinea and the Republic of Panama, convinced that the best way to strengthen peace and international security is through understanding, cooperation and friendly relations between nations, have decided to establish formal diplomatic relations, at the level of Non-Resident Ambassadors effective May 3, 1996.

These relations will be in accordance with the Vienna Convention on Diplomatic Relations of 1961.

Both Governments express their confidence that this agreement will contribute to the strengthening of mutual cooperation in the economic, commercial and cultural areas between the two countries which share the same objectives and goals of promoting peace, democracy, justice and solidarity in their relations, in accordance with the rules and principles of International Law.

IN WITNESS WHEREOF, the undersigned have signed this Joint Communique in the English and Spanish languages, both texts being equally authentic.

Done at New York on this 3rd day of May 1996.
