The Government of His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam and the Government of the Kyrgyz Republic, guided by the principles enshrined in the Charter of the United Nations and desirous of promoting a spirit of mutual understanding and of strengthening the existing bonds of friendship between the peoples of the two countries, have decided to establish diplomatic relations at Ambassadorial level as of the date of signing of this Joint Communiqué.
