## PROTOCOL

### on the Establishment of Diplomatic Relations between the Hashemite Kingdom of Jordan and the Republic of Belarus

The Hashemite Kingdom of Jordan and the Republic of Belarus,

Being desirous to promote relations of cooperation between the two countries,

Being committed to the purposes and principles of the United Nations Charter,

Have agreed

To establish diplomatic relations between the two countries at the level of ambassadors in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961.

Done at New York on October 15, 1996 in duplicate each in English and Belarusian, both texts being equally authentic.
