



## Report of India on the implementation of Security Council resolution 2397 (2017)

- 1. India is committed to the implementation of Security Council resolutions 1718 (2006), 1874 (2009), 2087 (2013), 2094 (2013), 2270 (2016), 2321 (2016), 2371 (2017), 2375 (2017) and 2397 (2017) relating to the Democratic People's Republic of Korea. National reports were submitted to the Security Council Committee established pursuant to resolution 1718 (2006) in February 2007, June 2010, April 2017 and December 2017.
- 2. Following the adoption of resolution 2397 (2017), the Government of India held inter-agency consultations regarding its commitments and obligations under the relevant resolutions on the Democratic People's Republic of Korea.
- 3. The specific legislative measures taken recently by India to implement effectively the provisions contained in resolution 2397 (2017) are as follows:
- (a) Order dated 5 March 2018 (S.O. No. 975(E)) issued by the Ministry of External Affairs of the Government of India under the United Nations (Security Council) Act, 1947. The Order enables the implementation of measures relating to, inter alia, asset freezes, travel bans, financial services, shipping, sectoral prohibitions and work authorizations. The Order is available in the public domain (www.mea.gov.in);
- (b) Notification No. 52/2015-20 dated 7 March 2018 (S.O. No. 1019(E)) issued by the Directorate General of Foreign Trade of the Government of India under the Foreign Trade (Development and Regulation) Act, 1992. The Notification seeks to specifically regulate trade (exports and imports) with the Democratic People's Republic of Korea to ensure effective compliance with the measures specified in the relevant resolutions on the Democratic People's Republic of Korea. The Notification is available in the public domain (www.dgft.gov.in).
- 4. The competent authorities of the Government of India have been informed of the legislative measures outlined in paragraph 3. Those authorities will ensure that the relevant provisions of the resolutions on the Democratic People's Republic of Korea are implemented in letter and spirit and in accordance with relevant domestic laws, regulations and administrative procedures.
