JOINT COMMUNIQUE
on the establishment of diplomatic relations between
the Socialist Republic of Viet Nam and Barbados

Desirous of developing and promoting friendship, understanding and mutual cooperation between their two peoples in accordance with the purpose and principles of the United Nations Charter and the provisions of the Vienna Convention on diplomatic relations of April 18, 1961;

The Socialist Republic of Viet Nam and Barbados have agreed to establish diplomatic relations between the two countries at the Ambassadorial level as of August 25, 1995.

Done at New York on August 25, 1995 in duplicate, each in vietnamese and english, both texts being equally authentic.
