
**Excellency:**

We have the honour to present our compliments to you and to request your kind assistance in having the following text of the joint communique on the establishment of the diplomatic relations between the Government of Turkey and the Government of the Republic of Seychelles, which is published simultaneously today by the two Governments, be circulated as a United Nations document:

"The Government of Turkey and the Government of the Republic of Seychelles, being desirous of promoting their existing friendly relations, have agreed to establish diplomatic relations with effect from June 22, 1995. Both Governments have agreed at a time convenient to both countries to appoint non-resident ambassadors as their respective Representatives.

THE GOVERNMENT OF TURKEY AND THE GOVERNMENT OF THE REPUBLIC OF SEYCHELLES, BEING DESIROUS OF PROMOTING THEIR EXISTING FRIENDLY RELATIONS, HAVE AGREED TO ESTABLISH DIPLOMATIC RELATIONS WITH EFFECT FROM JUNE 22, 1995. BOTH GOVERNMENTS HAVE AGREED AT A TIME CONVENIENT TO BOTH COUNTRIES TO APPOINT NON-RESIDENT AMBASSADORS AS THEIR RESPECTIVE REPRESENTATIVES.


