**PROTOCOL
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE KINGDOM OF CAMBODIA AND
THE REPUBLIC OF BELARUS**

The Kingdom of Cambodia and the Republic of Belarus following the mutual desire to develop friendship and cooperation in political, economic and cultural fields,

On the basis of the principles of mutual respect, territorial integrity and non-interference in each other's internal affairs as well as in accordance with the norms of international law and principles of the Charter of the United Nations,

Agreed to establish diplomatic relations in accordance with the Vienna Convention on Diplomatic Relations of April 18, 1961.

The Kingdom of Cambodia and the Republic of Belarus express their confidence that the establishment of diplomatic relations between them meets their national interests and will promote the development of international cooperation.

Done at New York on the 25th day of January, 1995 in two copies, each in Khmer, Belarusian and English languages, all texts being equally authentic.
