It was based on the principle of free choice of means while taking into account the realities in the international community with regard to compulsory jurisdiction, meaning that it was hardly likely that a third party could play a positive role in the settlement of a dispute without the express agreement of the parties directly concerned. The Declaration took duly into account experience gained in the peaceful settlement of disputes, which had shown that some procedures were more suitable than others and that sovereign States were free to choose the peaceful means that they deemed appropriate. It made it possible in any case to reach an early and equitable solution. It gave guidance in the sense that, whatever procedure was used, the solution had to be based on equitable principles and therefore had to be aimed at increasing respect for fairness and justice in the exercise of rights. Solutions likely to be considered by the parties as inequitable were difficult to implement, did not survive the test of time and could give rise to further disputes. Finally, the Declaration emphasized the supreme importance of direct and meaningful negotiations between the parties to a dispute as a flexible and effective means of peaceful settlement, since they were bound to enter into them with an agreement in view, not simply hold formal negotiations to resolve their differences. The parties were compelled to conduct themselves in such a way as to make negotiation meaningful, which it was not when one of them persisted in its own position without considering the possibility of any change.
