**JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC
RELATIONS BETWEEN THE REPUBLIC OF EQUATORIAL GUINEA AND THE
REPUBLIC OF SINGAPORE**

The Republic of Equatorial Guinea and the Republic of Singapore,

Desirous to promote mutual understanding and strengthen the friendship and cooperation between the two countries; and

Guided by the principles and purposes of the United Nations Charter and international law, particularly the respect and promotion of international peace and security, equality among States, due respect for national sovereignty and territorial integrity, independence and international treaties to which both States are party, and non-interference in the internal affairs of States;

Have decided to establish diplomatic relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Joint Communiqué.

In witness whereof, the undersigned representatives, duly authorized by their respective authorities, have signed this Joint Communiqué in two originals in the Spanish and English languages, both texts being equally authentic.

COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE LA REPÚBLICA DE GUINEA ECUATORIAL Y LA REPÚBLICA DE SINGAPUR

La República de Guinea Ecuatorial y la República de Singapur,

Deseosos de promover el entendimiento mutuo y fortalecer la amistad y cooperación entre los dos países; y

Guiados por los principios y propósitos de la Carta de las Naciones Unidas y el derecho internacional, particularmente el respeto y promoción de la paz y la seguridad internacionales, la igualdad entre los Estados, el debido respeto a la soberanía nacional y la integridad territorial, la independencia y los tratados internacionales en los que ambos Estados son parte, y la no injerencia en los asuntos internos de los Estados;

Han decidido establecer relaciones diplomáticas, de conformidad con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961, a partir de la fecha de la firma del presente Comunicado Conjunto.

En fe de lo cual, los representantes abajo firmantes, debidamente autorizados por sus respectivas autoridades, han firmado este Comunicado Conjunto en dos originales en los idiomas español e inglés, siendo ambos textos igualmente auténticos.
