JOINT COMMUNIQUE
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE PEOPLE'S REPUBLIC OF BENIN AND
THE MONGOLIAN PEOPLE'S REPUBLIC

The Government of the People's Republic of Benin and the Government of the Mongolian People's Republic, desirous of further strengthening the ties of friendship and co-operation between their respective countries and peoples on the basis of the principles of mutual respect for independence, sovereignty, non-interference in each other's internal affairs, equality and mutual advantage, have decided to establish diplomatic relations at the ambassadorial level as of today.
