REPORT

- 1. The first meeting of the Bureau and the General Rapporteurs of the Ad Hoc Group of Experts on the Supply and Use of Gas was convened following the decision of the joint Meeting of Experts on the Use and Distribution and the Transport and Storage of Gas, held in September 1998 (ENERGY/WP.3/GE.2/1998/2: ENERGY/WP.3/GE.3/1998/2, para.21 (d)).
- 2. The meeting was attended by representatives of the following countries: Croatia, Hungary, Netherlands, Poland, Russian Federation and Slovenia.
- 3. Chairman of the Group: Mr. Ante ZEDELJ (Croatia); Vice-Chairperson: Mrs. Maria Teresa SAO PEDRO (Portugal), who was not in attendance.
- 4. The meeting discussed the programme of work of the Ad Hoc Group of Experts and its projects underway, and approved the following decisions:

I. <u>Construction, management and maintenance of gas transportation systems - Diagnostics of gas transmission lines</u>

5. <u>Decisions</u>:

- (a) To thank Mr. Danilo Skerbinek, Rapporteur from Slovenia, for the preparation of a draft consolidated report;
- (b) To take note that the delegation of Netherlands will send a reply to the questionnaire by the end of February 1999;
- (c) To invite Mr. Skerbinek to send to the secretariat, before 31 March 1999, a revised version of the draft consolidated report, to be circulated to countries before 10 April 1999, for their comments;
- (d) To invite Mr. Skerbinek to prepare a new version of the consolidated report before 1 June 1999, for discussion at the first session of the Ad Hoc Group of Experts in January 2000.
